**PUBLIC NOTICE**

**Subject :** Display of Scanned Images of OMR Answer Sheet and facility to challenge the Provisional Answer Keys of the CET Examination - 2022 held on 05 and 06 November, 2022 for Group "C" Posts.

1. The CET Examination-2022 for Group "C" Posts was held on 05<sup>th</sup> and 06<sup>th</sup> November, 2022. The Provisional Answer Keys, Scanned Images of OMR Answer Sheets are now hosted on the Website(s) <https://hssc22.samarth.ac.in> and/or [www.hssc.gov.in](http://www.hssc.gov.in). Further, an opportunity is provided to the interested candidates to challenge the Provisional Answer Keys of any question ONLINE only. The Candidates shall be required to pay online an amount of Rs. 100/- (Rupees One Hundred Only) per answer key challenge as processing fee (non-refundable), as per the following schedule & details:

2. To facilitate the candidate, scanned image of the OMR Answer Sheet of candidate will be made downloadable for the candidate during above period on the respective log in of the candidate. Image of OMR Answer Sheet has also been sent to the appeared candidates on their registered Email ID.
3. Candidates will be given an opportunity to make an online challenge against the Provisional Answer Key by paying a non-refundable processing fee of Rs.100/- per answer challenged, within a specified period as indicated in the Public Notice.
4. The detailed information along with the procedure for the challenge of Answer Key is attached at Annexure- A. Candidates can submit their challenge, if any, only through ONLINE mode within the stipulated time period and on payment of fee. Any other mode of challenge submission will not be accepted. No communication/grievance with regard to Provisional Answer Key if submitted through any other mode or after the last date of online submission of Answer Key challenge, will be entertained. No objection filed without the fee shall be considered.
5. Challenges made by the candidates to any Answer Key will be checked / verified with the help of a panel of Subject Expert(s). If the challenge to any Answer Key is found correct, the Answer Key will be revised accordingly. Based on the Revised/ Final Answer Key, the Result will be prepared.
6. The Answer Keys after the challenges, as settled by the panel of Experts, will be treated as final and no further communication/ grievances shall be entertained with regard to Final Answer Key after the declaration of Result. There shall be no individual intimation to any candidate in response to his/ her Answer Key Challenge, if the same has been rejected/accepted by the Subject Expert(s).

**Procedure for Challenge of Answer Key**

1. Please go to the website <https://hssc22.samarth.ac.in> or [www.hssc.gov.in](http://www.hssc.gov.in)
2. Login with your Registration **Number and Date of Birth** and enter Security Pin as displayed and Submit.
3. Click ‘Apply for Answer Key Challenge(s)’
4. You will see 100 Questions in sequential order
5. The number next to the Question under the column ‘ *Correct Option/Answers* ’ stands for the correct/most appropriate Answer Key to be used for compilation of result.
6. If you wish to challenge this option, you may use anyone or more of the Options given in the next four columns by clicking the checkbox
7. You may upload supporting documents in which you can select ‘Choose File and upload (**all documents to be put in a single pdf file only**)’.
8. After clicking your desired option, for CET 2022, ‘**Save your Claim**’ and move to the next screen.
9. You will see a screen displaying your **challenges**.
10. Click on ‘**Save your Claim and Pay Fee Finally**’.
11. Select Mode of Payment and Pay a processing fee @ **₹ 100/-** for each question challenged. Make payment through Debit/Credit Card/Net Banking/Paytm.
12. After successful payment, download/print the Answer Key challenge receipt.
