The following information is also for the Candidates, that:

1. Each candidate can view her/his own attempted OMR Sheet, and Roll Number-wise Score of Written Exam based on the answers attempted in the OMR Sheets.
2. District-wise final merit will be prepared after document verifications to be conducted as per the schedule given in the advertisement and subject to the availability of seats in particular District & Category.
3. Candidates are required to attend their Document Verification as per District-wise Schedule to be given in the forthcoming Public Notice(s). If any candidate don't appear for document verification as per given schedule, her/his candidature may be rejected without any further information.
4. Candidates for claiming benefit of reservations under BC-A/BC-B/EWS/ESM/PH Categories are hereby advised to obtain their required latest Certificates alongwith Haryana Domicile from the Competent Authorities, as per instructions given in the advertisement. To avail the benefit of reservation under Scheduled Caste category, candidates are required to produce their own Scheduled Caste Certificate at the time of document verification. All documents produced at the time of document verification should be clearly readable, otherwise will be summarily rejected and no additional time will be given to any of the candidate for this purpose.
5. **The candidates with academic qualifications as per Sr. No. 2.1 & 2.2 given in the advertisement are required to provide their Valid Certificates to ensure their eligibility for Six Months BPCCHN from IGNOU or any University / Institution assigned by the State, or MLHPs Course integrated in their Curriculum of Basic BSc /Post-Basic BSc Nursing curriculum in reference of the Circular/Notifications issued by the Indian National Nursing Council, New Delhi in 2019 in compliance with the directions of the MoHFW/GoI. The additional 05 marks will be considered for the said qualification(s), only after production of the valid certificate of BPCCHN or MLHP Course at the time of Document Verification, which is final stage for considering additional 05 marks, and no additional time will be given to any of the candidate for this purpose.**
6. For producing an invalid or fake certificate to claim additional 05 marks (i.e. Other than BPCCHN issued by IGNOU or State University/Institution, or MLHP Certificate integrated in the curriculum of Basic/Post-Basic B.Sc. Nursing), legal and administrative action will be initiated by way of (i) Lodging FIR with Police against candidate and Certificate issuing Authority, and (ii) Candidature of such candidate shall be rejected at the time of document verification and her/his seat shall be transferred to the next candidate in order of merit. Therefore, all candidates are hereby advised to avoid from producing any fake/invalid Certificate at the time document verification.
